Southwest Florida Women Giving Together ("SWFL WGT" or "Giving Circle") is a fund of the Greater Naples AAUW Charitable Foundation, Inc. (the "Foundation"), a public charity which promotes equity, education and development of opportunities for women and girls that enable them to realize their full potential by: Awarding academic scholarships to deserving local women;

Supporting the AAUW Greater Naples Branch STEAM Girls Count Conference for fifth-grade girls enrolled in Collier County Public Schools, teaching them and their parents about opportunities in science, technology engineering, arts and mathematics;

Supporting the AAUW Greater Naples Branch Reading is Fun program, giving new books to at-risk children in local public elementary schools; and

Supporting the AAUW StartSmart and AAUW WorkSmart programs, teaching woman salary negotiation skills to help close the persistent gender wage gap.

#### Terms

This agreement comes into effect when it is signed by both parties and will renew automatically each year unless terminated by either party at any time.

Participants in the SWFL WGT are not required to remain in the group year after year, though the fund would be most successful supporting multi-year programming commitments through donors' continuous participation. A donor may drop out of SWFL WGT at any time and rejoin at a later date; however, dues are not refunded if participation is discontinued.

#### The Donor

The Donor will contribute non-refundable annual dues of \$250 to Greater Naples AAUW Charitable Foundation, Inc./SWFL WGT. By doing so, the donor will join other Giving Circle members to support the community service programs described above. Dues shall be paid by check made payable to Greater Naples AAUW Charitable Foundation, Inc., marked "Giving Circle" or "SWFL WGT," and mailed to the address above.
