—Name a one-time scholarship for just \$1500 or establish an endowed scholarship fund for a minimum of \$25,000. Contact Laura Candris, <u>laura\_candris@msn.com</u>, for details.

—**Make a gift to the Foundation in your will or living trust.** You may specify a gift of a specific dollar amount, a percentage of what is left after other distributions have been made, or a particular asset. You may be able to add a charitable gift to an existing will through a simple amendment. Suggested wording for your attorney to consider: "After fulfilling all other specific provisions, I give, devise and bequeath \_\_% of the residue [or \$\_\_] to the Greater Naples AAUW Charitable Foundation Inc., a 501(c)(3) public charity, incorporated in Florida, having a mailing address of P.O. Box 9742, Naples, FL 34101."

—Name the Foundation as a beneficiary of your retirement plan. When you leave the balance of an IRA or 401(k) to your heirs, they must carefully manage the account to avoid losing its tax-de-ferred status and potentially triggering income taxes and possible penalties. You can simplify matters for your loved ones by directing all or a portion of what remains in your retirement account to the Foundation and leaving other more tax-favored assets to your heirs.

#### One Resolution You Should Keep: Reviewing Your Estate Plans.

You may need to amend your will for a number of reasons, including changes in your property, your address, the needs of your loved ones, the composition of your family or applicable laws. When you need to amend your will for other reasons, consider adding a gift to the Foundation.
