**Memorandum of Understanding ("MOU") between
the Greater Naples AAUW Charitable Foundation, Inc. and the Donor Participating
in the Southwest Florida Women Giving Together Giving Circle**

Southwest Florida Women Giving Together ("SWFL WGT" or "Giving Circle") is a fund of the Greater Naples AAUW Charitable Foundation, Inc. (the "Foundation"), a public charity that promotes equity, education and development of opportunities for women and girls that enable them to realize their full potential by supporting mission-focused local charitable programs.

Terms

This agreement comes into effect when it is signed by both parties and will renew automatically each year unless terminated by either party at any time.

Participants in the SWFL WGT are not required to remain in the group year after year, though the fund would be most successful supporting multi-year programming commitments through donors' continuous participation. A donor may drop out of SWFL WGT at any time and rejoin at a later date; however, contributions are not refunded if participation is discontinued.

The Donor

The Donor will make a non-refundable annual contribution of \$250 or more to Greater Naples AAUW Charitable Foundation, Inc., for the SWFL WGT. By doing so, the donor will join other Giving Circle members to support the community service programs of the AAUW Greater Naples Branch. The annual contribution shall be paid by check made payable to Greater Naples AAUW Charitable Foundation, Inc., marked "Giving Circle" or "SWFL WGT," and mailed to the address above.

Use of Funds

The active members of the Giving Circle collectively make recommendations to the Foundation on the disbursement of the Giving Circle funds.

A member is active for the 12-month period beginning on the original date of his or her joining, or rejoining after an absence, provided that she or he has also signed this MOU.

Eighty percent of the revenue collected as contributions from Giving Circle participants will be used to support mission-focused local charitable programs.

Twenty percent of the revenue collected as contributions from Giving Circle participants will be used for other Giving Circle events and administrative expenses.
