The Greater Naples AAUW Charitable Foundation, Inc. ("Foundation") offers named scholarship opportunities for a minimum donation of just \$2,000.

Since 2001, the Foundation has annually awarded scholarships to local women, age 21 and over, who are pursuing degrees at an accredited college or university and who demonstrate academic achievement and financial need.

The Foundation also annually awards scholarships to deserving local women of any age who demonstrate academic achievement and are pursuing degrees in science, technology, engineering, or mathematics.

Additionally, the Foundation awards scholarships to deserving local women who are pursuing teacher certification and who demonstrate academic achievement and financial need.

Make your donation of \$2,000 or more by February 15 for a scholarship to be awarded the following April. You may designate a Scholarship for Women age 21 or over, a STEM Scholarship or a Future Teacher Scholarship.

- Named Scholarships are awarded as the "XYZ Company Scholarship of the Greater Naples AAUW Charitable Foundation, Inc." or the "Jane X. Doe Scholarship of the Greater Naples AAUW Charitable Foundation, Inc."

- Donations designated for scholarships with no other designation will go into the scholarship fund selected by the Foundation Board on the recommendation of the Scholarship Committee.
- Your donation is tax-deductible to the extent allowed by law.

Make your check payable to Greater Naples AAUW Charitable Foundation, Inc., marked "Named Scholarship" and mail it to the address above with the type of scholarship and the name of your choice.
