The Foundation awards three types of scholarships to deserving local women who are pursuing degrees at an accredited college or university and who meet the eligibility criteria, published at https://greaternaples-fl.aauw.net/scholarships/:

- 1. Scholarships for Women Aged 21 or over who are pursuing degrees in any field.
- 2. STEM Scholarships for women of any age who are pursuing degrees in science, technology, engineering, or mathematics.
 - 3. Future Educator Scholarships for women of any age who are pursuing teacher certification.

Make your donation of \$2,000 or more by February 15 for a scholarship to be awarded the following April. You may designate a Scholarship for Women age 21 or over, a STEM Scholarship or a Future Educator Scholarship.

- Named Scholarships are awarded as the "XYZ Company Scholarship of the Greater Naples AAUW
 Charitable Foundation, Inc." or the "Jane X. Doe Scholarship of the Greater Naples AAUW Charitable
 Foundation, Inc."
- The Foundation's eligibility criteria, policies and rules for scholarships apply. Proposed names for Named Scholarships are subject to approval by the Foundation. Scholarship eligibility criteria are posted at https://greaternaples-fl.aauw.net/scholarships/.
- Donations designated for scholarships with no other designation will go into the scholarship fund selected by the Foundation Board on the recommendation of the Scholarship Committee.
- Your donation is tax-deductible to the extent allowed by law.
